- 1.) I agree to abide by the rules and regulations of 365 Sports Inc., Van Vleck Ranching and Resources Inc, and subsidiaries and those affiliated with conducting the Activities, without limitation to their officers, officials, directors, agents, employees and volunteers, other participants, sponsoring agencies, sponsors, advertisers, venue lessee/owner/lessor and their employees (hereby known as Released Parties) and agree to use the facility/equipment in a manner consistent with its intended use:

- 4.) I recognize the 5K FOAM FEST USA is a physical activity designed predominantly for athletic, healthy individuals. I warrant I am in good physical and mental health and I do not suffer from any disability or physical problems that could make it hazardous for me to participate and I agree to participate in the Activities of on my own free will. I further warrant I am not taking any prescription or non-prescription drugs, including any controlled substances, which may impair my ability to participate in the activities. NOTE: If you have been inactive, pregnant or if you have medical problems, you are advised to consult with your physician before taking part in the Activities;
- 5.)
